

**FILING INSTRUCTION
FOR
DETERMINATION OF APPLICABILITY**

Work you are proposing on your property is within the 100' Buffer Zone of a Wetland Resource Area and requires the filing of a Request for Determination of Applicability under the state and local Wetlands Protection Act/Ordinance

Submittal requirements to the Conservation office:

- 9 copies of both the local and state application forms
- 9 copies of a plan or sketch showing the location of the proposed work

Filing fee as per Chapter 12, Section 10 (see below)

Upon receipt of the above in the Conservation office, a legal notice shall be prepared and given to the applicant. It is the applicant's responsibility to submit this to the Lawrence Eagle Tribune for publication. A copy of the legal notice posted in the newspaper must be submitted to the Conservation Commission at the opening of the public meeting for your project.

In addition:

One (1) copy of the state application form and a copy of the plan or sketch must be mailed to D.E.P., NERO – Wetlands Division, 205B Lowell Street, Wilmington, MA 01887.

FILING FEE SCHEDULE

1. For addition, accessory structures, pool, septic and earthwork (\$55.00 for each activity).
2. New single family dwelling and associated work (\$100 per lot*).
3. Addition, parking lot, earthwork to non-residence (\$100 per activity*).
4. New non-residential building & associated work (\$200 per activity*).

* PLUS Buffer Zone Fee of 0.05/sq/ft of alteration.
