These units run on freon, which is no longer allowed under EPA regulations. These units have been repaired several times and parts are no longer available. This solution will be able to detect active gunfire within a specified geographical area of Methuen and send this data to Police Dispatchers to create a call for service. Police	90 Hampshire Street	Equipment	Records management system (purchase and implementation yr 1)	Methuen Police Department will be replacing three separate systems with one fully integrated CAD (dispatch), RMS (records management/reporting) and Jail (arrest processing) system. The new CAD/RMS will be an approved MA DCJIS vendor, with capability to transmit criminal complaints, E-citations, and crash reports electronically. The replacement system will provide robust analytical functions for reporting within the agency and to external partners and the public. The system will be cloud native and will allow the police department and fire department to share a CAD system. The shared CAD will improve communication of data between our agencies and increase efficiency. This upgrade is critical to improve data quality, reduce time dedicated to report writing and data entry, and integrate our systems for bi-directional information sharing.	5	\$ 475,000.00
