We the Subscribers Selectmen of Methuen, at the request of a number of the Inhabitants of Said Town, have laid out a Town road as follows. Beginning at a stake and stones by the Town road near Joshua Swan's shop: thence south five degrees west, thirteen poles, on the eastward side of a stone wall, thro' Said Swan's land to a stake & stones, thence south one degree east, thro land of Ebenezer Savory, thirty two poles to a stake & stones by land of Capt. Henery Bodwell, thence south sixteen degrees east twenty one poles to a stake & stones, two rods westerly from a stone wall, thence running south eight degrees

east thirty two poles, to a walnut tree by the Town road. - The Said road laid out two rods wide on the easterwardly side of all the above mentioned bounds, till it comes to the last mentioned bound where it is two rods and a half on the eastwardly side of the same.

School Regulations Preamble

As the Town of Methuen are annually at a considerable expence (expense) to support their schools it appears necessary to bestow a particular Att (At)entions that the money raised for that purpose should be employed to the best advantage. The authority of this State have in their wisdom been pleased to enact such laws as may operate for the general good & regulations of the several towns and schools throughout this Commonwealth – giving at the same time liberty for each Town to make such additions & regulations as may be more conducive to the good order & improvement of their particular schools – Therefore the present School Committee have thought it necessary & proper to throw together a few articles in conformity to the above mentioned law for the particular government improvement of the several schools in Methuen – which they humbly beg leave to present for the consideration & acceptance of the Town –

Section I - Concerning the Duty of the School Committee

- Article 1st It shall be the duty of the School Committee to visit the several Town Schools in each District twice every year & more if necessary giving seasonable notice to the Master or Mistress
- 2nd It shall be the Duty of the Committee to enquire into the regulations the mode of

Government & the method instructions practiced in the school (it is specified in an act

of the General Court) and it shall be the duty of the Committee to use their best endeavours to correct any deficiency in the mode of government the manner of Instruction or the Discipline of the Schools -

3rd Should any Master or Mistress appear so essentially deficient in the mode of government the method of instruction or the discipline of the school as not to be useful:

It shall be the duty of the Committee & Selectmen a majority of them concerning to

dismiss him or her from the school and the Committee or the Selectmen shall provide

another who may be more useful –

4th It shall be the duty of the Committee to close each visit to the School with addressing themselves to the Scholars upon the Duty of Order the necessary respectability and advantages of good education –

Section II - Concerning the duty of School Masters –

1st It shall be the duty of every School Master to open his School in the morning & close it in the evening with prayers

2nd It shall be the duty of the Master or Mistress to adopt such general regulations as will have tendency to operate uniformly throughout the whole school that every one may have an equal chance to pursue & improve in his particular branch of study & be subject to the same rules of government.

3rd The Instructor shall endeavour to govern his respective school by the skillfulness of his hand and the integrity of his heart with using as little severity as he shall judge will be for the best good of the school but where mild measures will not subject the idle to the good order regulations of the school the Instructor shall have a right to inflict reasonable & decent corporal punishment –
