The Report of the committee whose duty it was to report on this article was read by chairman, E. Sawyer.

Voted that the whole subject relating to fires be passed over till the next annual meeting

Voted that the subject pertaining to fires be recommitted to the same committee and that they report at the next annual meeting.

The Report is as follows.

Your committee appointed at the last Town Meeting to consult with Mr. Nevins about the use of his force pumps in cases of fire, and to estimate the cost of laying iron pipes in different sections of the village have attended to that duty, and beg leave to report that we have seen Mr. Nevins, who expresses himself as willing to render any assistance in his power in all cases of fire in the village, by the use of his Force Pumps if the Town will lay down iron pipes to connect with his pumps.

We have consulted with some of the best Engineers and Machinists of Lawrence, about the power of force pumps, and the proper sized pipes to be used, and have come to the conclusion that 4 inch cast iron pipes in joints of eight feet in length weighing about thirty lbs per foot will be the size necessary to be laid down 3-1/2 or 4 feet deep with hydrants to come up at convenient distances on the line to connect hose. Your committee after examining all the localities of property situated in the village have come to the conclusion that there should be four lines of pipes from the Factory extending in the following directions,

First from the North Factory yard to near the residence of Mr. Dean Chase	600 feet
Second from same starting point to near Stone Church	900 feet
Third from East side of the Factory to East corner of the High School	900 feet
Fourth from West side of the Factory to Railroad Square	550 feet
Making in all about	2950 feet

Report of the Committee to report on articles No. 8th, 13th-15th-16th in the warrant for the Annual Town Meeting.

Have carefully considered and investigated the several subjects introduced by said articles, and have unanimously agreed to submit the following report.

First, article 8th relating to the purchase of a steam fire Engine, and all other matters pertaining to the Fire Department.

You committee have endeavored to ascertain the condition of our present Fire Engines, Hose etc the outlay that would be necessary to fix them for efficient use, and also the annual cost for maintaining companies and incidental expense. We have estimated that it will cost the Town for Fireman's services and incidental expenses \$900. per annum both engines properly manned, and \$600 a year for the Spiggot alone. We estimated that both engines can be put in good order for use for twenty five dollars. The suction hose appears to be in fair condition. There is no leading hose reliable except about one hundred feet of linen. In the opinion of your committee five hundred feet of hose must be purchased at an expense of one 00/100 dollars per foot, amounting to seven hundred and fifty dollars.

We further estimate that the present engine property could be sold for

We estimate that a Steam Fire Engine can be kept in good order and operated for \$280. per annum.

Difference in expense of operating a Steamer and our present Engines about as follows.

Leaving a difference of	\$ 620

Or the interest at 7 per cent on nearly nine thousand dollars.

The difference in required appropriations for immediate use would be about as follows.

In considering article 10th in relation to digging wells. We have estimated the cost about as follows.

The cost of digging two wells 20 feet in depth and 6 feet in diameter furnished with pumps and troughs for the same would be \$125 each \$250 for the two.

The proper location in our judgment would be one near the hay scales and the other near the store of G. W. Sawyer.

In reporting upon article 16 we would make the following report as to cost.

In considering article 16th with the present occupancy of the Town Hall Building we find no suitable place for a fire proof brick vault, and find that the Town can purchase two fire proof Iron safes at an expense of \$525. Such safes would be of sufficient capacity to contain all the records and the most important of the public documents reports and so forth belonging to the Town.

Having attended to the duties assigned us we leave the matter for your consideration.

The Committee who were appointed by the Selectmen to take into consideration the subject matter of highways and the manner of raising and expending money for the repair of highways, - present the following Report they would recommend that the Selectmen be authorized to appoint a committee of three to act as road commissioners one from the east part of the Town, one for the west part and one for the village, who shall have the general supervision of the repairs of highways and bridges; and that all highway taxes be paid in money to the Town Treasurer and that the said committee be instructed to employ in such repairs, persons living in the immediate vicinity of such repairs, provided the services of such persons can be procured on terms equally as favourable as can be obtained elsewhere; and that all bills for labor be approved by the said Committee before being paid by the Selectmen.

- Art. 7 Voted that the Collector of taxes be authorized to collect all delinquent highway taxes, the same to be appropriated agreeably to the vote on Article 6 of this Warrant.

Art. 8 Voted that the Selectmen be authorized to hire in behalf of the Town a sufficient sum of money to pay any notes that may become due during the year, or that may be necessary to pay orders drawn by the Selectmen, and that the Treasurer be empowered to sign such notes in behalf of the Town.

Art. 9 Voted to approve and accept the list of Jurors submitted by the Selectmen, as liable to serve as Jurors the year ensuing.

Art. 2 Voted that the Town approve the rules and regulations established by the board of Engineers appointed by the Selectmen and that they be published under the direction of the Board of Engineers.

Art. 3 Voted to appropriate one hundred and fifty dollars for Lighting the Street of the village, the same to be laid out under the direction of the Selectmen.

Voted to Adjourn.

Rules And Regulations of the Methuen Fire Department
Adopted May 2, 1871 and approved by the Town May 22nd 1871

- Art. 1 The Engineers, as soon as practicable after their appointment, shall meet and organize themselves into a Board of Engineers, by the choice of a Chief Engineer, Assistant and a Clerk, who shall hold their respective offices for the year ensuing and until others are elected in their stead.

Art. 2nd The Chief Engineer may call meetings of the Board whenever he may deem it expedient, and by the request of two members of the Board.

Art. 3rd A majority of the Board shall be present at any of the meetings in order to constitute a quorum. The Chief shall preside at all meetings of the Board when he shall be present, also give the casting vote in case of a tie, and in his absence the Assistant Engineer present shall be the presiding officer.

Art. 4th The Engineers shall have general superintendence and control of all the Engine and other houses used for the purpose of the Fire Department, and of all the furniture and apparatus thereto belonging; and of the Engines, and all other apparatus belonging to the Town.

Art. 5th It shall be the duty of the Chief Engineer to visit or cause to be visited by one of his assistants, all the companies belonging to the Fire Department, at their regular monthly meetings, for the purpose of ascertaining the condition of the apparatus, and for furnishing all necessary supplies; also, to ascertain the number and standing of its numbers.

Art. 6th It shall be the duty of said Engineers whenever a fire shall break out in the Town, to repair forthwith to, or near the place where the fire may be, to take proper measures that the several Engines and other apparatus be arranged in the most advantageous situations, and duly worked for the extinguishment of the fire; and to require and compel assistance from all other persons, as well as members of the Fire Department, in extinguishing the fire or moving furniture, goods and other merchandise, from the buildings on fire, or in danger thereof, and to appoint guards for the security of the same; also to require and compel assistance in pulling down and demolishing buildings if necessary, and in suppressing all tumults and disorders, that may occur at a fire.

Art. 7 The Chief Engineer shall have the sole command of fires over all other Engineers, all members of the

Fire Department, and all other persons who may be present at fires, provided, however, that no building shall be pulled down or demolished without the concurrence of at least three Engineers.

- Art. 8 In the absence of the Chief Engineer, the Assistant shall execute the duties of his office, with full powers.
- Art. 9th It shall be the duty of the Chief Engineer, to keep or cause to be kept a record of all fires which may happen in the Town during the year, with the probable causes of the same, and a description of the buildings and property destroyed and injured, together with the names of the owners and occupants of such buildings; also, make an annual report of the same, together with the condition of the fire apparatus once a year, at the annual Town meeting.
- Art. 10th If any Engine or fire apparatus be so damaged that immediate repairs are necessary, it may be taken forthwith to a suitable person to be repaired; but no repairs shall be made until information of such damage is given to the Chief Engineer, that he may order or superintend such repairs, provided, that in case such information cannot readily be given to the Chief Engineer, it may be given to any other Engineer. All bills of any kinds are to be presented to the Chief Engineer immediately after the work is delivered.
- Art. 11th It shall be the duty of the Clerk to give notice of all meetings to each of the members, and to keep a true record of all business transacted at the meetings of the Board of Engineers; to notify persons of their appointment as members of the several companies; also, to send them a certificate of members signed by the Chief and Clerk of the Board of Engineers.
- Art. 12th The members of the several fire companies are strictly forbidden to assemble at any of the Engine houses on Sunday, except, in case of fire, or without the permission of an Engineer, and no repairs or work of any kind will be allowed on that day, without the consent of the Chief Engineer.
- Art. 13th It shall be the duty of the Foreman of the several companies, to demand of the company the discharge of any member who may be guilty of any disorderly or improper conduct, or use any disrespectful language to the Board of Engineers or officers of the company, and in case they refuse to discharge such members the Foreman shall at once report the same to the Board.
- Art. 14th Any member who shall be absent from three consecutive fires or meetings, unless detained by sickness of himself or family, shall be liable to be discharged from the Department.
- Art. 15th No person whose business is not within the limits of the Town of Methuen will be allowed to become or remain a member of the Fire Department.

Section II

- Art. 1st Each of the Fire Engine companies formed and appointed by the board of Engineers, shall have a Foreman, Assistant, Foreman and Clerk, who shall constitute the Officers of said Company, all of whom shall be chosen annually, and in the month of May, by written votes of their respective companies, at a special meeting held for that purpose; also at such time as vacancies may occur, and report the same to the Board of Engineers.

- Art. 2nd Each of the Steam Fire Engines shall have an Engineman, Assistant Engineman, Fireman and Steward, all of whom shall be appointed by the Board of Engineers, and shall hold their office until removed by the said Board.
- Art. 3rd Each of the Hose and Hook and Ladder companies, formed and appointed by the Board of Engineers, shall have a Foreman, Assistant Foreman, Clerk and Steward, all of whom shall be chosen annually, and in the month of May, by the written votes of their respective companies at a special meeting held for that purpose; also at such times as vacancies may occur, and report the same to the Board of Engineers.
- Art. 4th It shall be the duty of the Foreman of each of the companies of the Fire Department respectively, to see that the buildings entrusted to his care are kept clean and in order; to preserve order and discipline at all times, and to require and enforce a strict compliance with the rules, regulations and orders of the Board of Engineers.
- Art. 5th It shall be the duty of the Clerks of the respective companies, to notify members of all meetings; to keep an exact roll, specifying the time of admission and discharge of each member of their respective companies, and report the same within five days from the performance or said duty, to the Chief Engineer.
- Art. 6th The Enginemen of the steamers shall have sole care of their respective Engines, under the direction of the Board of Engineers. They shall be held responsible for the care and good order of the same, and see that they are at all times in condition for immediate use. The Enginemen shall run the Engines at fires or at other times when required; in their absence the Assistant Enginemen shall perform said duty. The Enginemen may have the privilege of recommending their Assistant.
- Art. 7th The Firemen shall be under the direction of the Enginemen while on duty. They shall prepare the fuel for the Engines, and have it at all times ready for use. In the absence of the Firemen the Foreman shall appoint a suitable person.
- Art. 8th It shall be the duty of the Steward to keep clean the house, hose, or other apparatus which may belong to the company; to clean the mow from the sidewalks connected with the house in winter, and perform such other duties as are incumbent on him.
- Art. 9th On the return of the Engines and other apparatus either from fires or drill, they shall by their Enginemen and Stewards, respectively, be well washed, cleaned, oiled, and securely housed; once in every month, said companies shall meet for the purpose of examining the state of their respective engines and other apparatus, and see that the same is in good order and fit for use, and to transact any business that may come before them.
- Art. 10th No company will be permitted to take their Engine or other apparatus out of Town without the permission of the Chief Engineer, or in his absence, the next in command.
- Art. 11th The Enginemen of each Company shall have the control of the engine, under the direction of the Engineers and the apparatus is not to be handled, used in any manner, or meddled with by members of that, or any other company, unless by permission of the Enginemen or of the Board of Engineers.

- Art. 12th If any member of either of the several companies shall willfully neglect or refuse to Discharge his duty, or shall be guilty of disorderly conduct, or disobedience to any officer, or to any Engineer, he shall, for such offence, be discharged from the Fire Department.
- Art. 13th No person shall be permitted to engage to serve in the Fire Department for a shorter period than three months, and if he shall be dismissed from his company before the expiration of the same, except it be on account of sickness or some other circumstances beyond his control, he shall forfeit all compensation which may have become due to him.
- Art. 14th The members of the several companies shall be furnished with a copy of the rules and regulations of the Fire Department. There shall also be a copy framed, and placed in the halls of the respective Engine houses.

Section III

- Article 1st It shall be the duty of the officers and members of the Fire Department, when an alarm of fire is sounded, to repair forthwith to the locality from which the alarm came, and if there proves to be a fire, they will conform to the directions of the Chief, and other Engineers, and exert themselves in the most orderly manner possible, in running and managing the Engines, Hooks and Ladders, and other apparatus, and in performing any other duty they may be called upon to do by an Engineer; and upon permission of the Chief or other Engineer, they shall, in an orderly and quiet manner, return said Engine and other apparatus to their respective houses, provided that, in the absence of all the Engineers, such direction and permission shall be given by the Foreman of the respective companies.
- Art. 2nd As a general rule it is recommended not to open the windows or doors of a building in which a fire may be, until a supply of water is obtained, and then carefully to abstain from injuring goods or furniture by its injudicious application.
- Art. 3rd The first Engines, on arriving at a fire, are to be drawn to the nearest supply of water, and there set in such a manner as will be satisfactory to the Chief or one of the Assistant Engineers the other Engines on arriving, to be placed in the same manner.
- Art. 4th Each Engine Company is to carry not less than four hundred feet of leading hose, the Hose Companies not less than six hundred feet.
