**Warrant for Annual Town Meeting, March second 1903, File 13
No. 8.**

Essex SS: To Amos G. Jones, one of the Constables of the Town of Methuen in said County:

Greeting: -

In the name of the Commonwealth of Massachusetts you are hereby directed to notify and warn the inhabitants of the Town of Methuen qualified to vote in elections and Town affairs, to meet and assemble at the designated polling places of Precincts One and Two namely: the Town Hall in voting Precinct One, and the basement of the Arlington School House in voting Precinct Two, on Monday the second (2) day of March next, at six (6) o'clock in the forenoon, to bring in to the election officers their votes for Town Clerk, Treasurer to the election officers their votes for Town Clerk, Treasurer, to the election officers their votes for Town Clerk, Treasurer to the election officers their votes for Town Clerk, Treasurer, Collector of Taxes, Selectmen, Assessors, Overseers of the Poor, Highway Surveyor, one School Committeeman to serve three (3) years in place of William D. Hartshorne, one Water Commissioner to serve three (3) years in place of Edwin J. Castle, one Trustee of Nevins Memorial to serve two (2) years in place of Lewis E. Barnes, one Tree Warden to serve one (1) year in place of Stephen J. Barker, Constables, Auditor, Fence Viewers, and Yes, or No, in answer to the question "Shall license be granted for the sale of intoxicating liquors in the Town?" All to be voted for on one ballot.

The polls may be closed at four (4) o'clock p.m.

Also to met at the Town Hall in said Town, on Saturday the seventh (7) day of March next, at one (1) o'clock in the afternoon, then and there to act on the following articles, viz.: -

Article 1 To choose a Moderator to preside at said meeting.

Article 2 To elect all Town Officers not required to be chosen by ballot.

Article 3 To hear the annual report of the Selectmen and act thereon.

Article 4 To raise such sums of money as may be necessary to defray Town charges for the ensuing year and make appropriations for the same.

Article 5 To determine the manner of collecting taxes the ensuing year and act thereon as the Town may think proper.

Article 6 To see if the Town will authorize the Town Treasurer with the approval of the Selectmen, to hire money in anticipation of taxes of the current municipal year, and to issue notes of the Town therefore.

Article 7 To see if the Town will vote to approve and accept the list of jurors prepared by the Selectmen for the ensuing year.

Article 8 To hear the reports of Committee and act thereon.

Article 9 To determine what compensation the Town will grant the members of the Fire Department for their services the ensuing year.

Article 10 To determine the manner of appropriating the amount received from dog taxes, in accordance with Chapter 102, Section 163 of the Revised Laws.

Article 11 By request of Col. William B. Greene Post 100 G.A.R., to see if the Town will vote to appropriate two hundred (200) dollars for the purpose of decorating the graves of our Soldiers and Sailors on Memorial Day, May 30, 1903, said money to be expended under the direction of the above Post.

Article 12 By request of Frank Remick and others, to see if the Town will vote to grade and macadamize High Street, from Hampshire to Stevens Street, with suitable drainage, and appropriate seven hundred dollars for the same.

Article 13 By request of Hugh F. Coburn and others, to see if the Town will vote to repair the macadam on Howe Street, from Marston's corner to Tozier's corner and appropriate twenty five hundred (2500) dollars for the same.

Article 14 By request of William P. Morse and others to see if the Town will vote to macadamize Lowell Street, from Railroad square to the corner of Lowell and Elm Streets, and appropriate three thousand (3000) dollars for the same.

Article 15 By request of Fred E. Koenig and others, to see if the Town will vote to macadamize Milk Street, from its intersection with Prospect and East

Streets to Baremeadow Street, and appropriate two thousand dollars for the same.

Article 16 By request of Charles E. Merrill and others, to see if the Town will vote to macadamize Hampstead Street from Grosvenor's Corner, north, past the Grosvenor School house and appropriate fifteen hundred (\$1500) dollars for the same.

Article 17 By request of Joseph E. Buswell and others, to see if the Town will vote to macadamize Brook Street, from Prospect Street to Jackson Street extension, and appropriate five hundred (500) dollars for the same.

Article 18 By request of Alfred Newsholme and others, to see if the Town will vote to grade and repair Lowell Street from Elm to Forest Streets, and appropriate eight hundred (800) dollars for the same.

Article 19 By request of A. J. Crosby and others, to see if the Town will vote to build a 12-room brick school-house on the site of the High School building on Lawrence Street, or other suitable location in that vicinity, the same to be completed for occupancy September 1st 1904, and appropriate fifty thousand (50,000) dollars for the same.

Article 20 By request of Joseph Stringer and others, to see if the Town will vote to build a suitable school house on the land already accepted for that purpose, situated on the Bradley Farm Platt, and appropriate five thousand dollars for the same.

Article 21 By request of Albert J. Richardson and others, to see if the Town will vote to macadamize Barker Street, from Pelham Street to Lowell Street, and appropriate eight hundred (800) dollars for the same.

Article 22 To see if the Town will vote to finish grading the sidewalk on the south side of Pleasant Street from near the back entrance of Mr. C. H. Tenney's estate to the entrance of Mr. Henry T. Lea's estate, the money to do the work to be taken from the regular appropriation for sidewalks.

Article 23 By request of James Robie, to see if the Town will vote to re-imburse him the sum of one hundred and twenty five (125) dollars for labor done on uncovering the ledge in 1891, at the present location of the stone crusher on Walnut Street.

Article 24 By request of the Arlington Mills, to see if the Town will vote to discontinue Stafford Street from the westerly line of Ingalls Street, to its termination.

Article 25 By request of the Arlington Mills, to see if the Town will vote to discontinue Ingalls Street, from the northerly line of Chase Street to its termination.

Article 26 By request of the Engineers of the Fire Department, to see if the Town will vote to purchase 500 feet of fire hose, and appropriate three hundred (300) dollars for the same.

Article 27 By request of John W. Bentley and others, to see if the Town will vote to place a fire alarm box on Pelham Avenue, near the house of Frank McDermott, and appropriate one hundred and fifty dollars for the same.

Article 28 By request of Andrew M. Hoh and others, to see if the Town will vote to place a fire alarm box at the corner of Milk and Dewey Streets, and make an appropriation for the same.

Article 29 To see if the Town will vote to appropriate two hundred dollars for street improvement in the Town of Methuen, the same to be expended under the direction of the Town Improvement Society.

Article 30 To see if the Town will vote to accept and adopt the Sewers as constructed in the Spicket River and Bloody Brook systems, and provide that assessments under Sections 3 and 5, of Chapter 49 of the Revised Laws may be made upon owners of estates within such territory.

Article 31 To see what action the Town will take towards securing legislation to enable it to create a Board of Public Works, to have charge and control of the Town Water Works, the Town Sewers, Playsteads, Public Parks, and shade trees, or any part thereof.

Article 32 To see if the Town will vote to establish the office of Sewer Commissioners under Section 341, Chapter 11 of the Revised Laws.

Article 33 By request of Sidney Payne and others, to see if the Town will vote to construct a culvert across Oak Street, between Cook's corner and Channing Street, and appropriate fifty (50) dollars for the same.

Article 34 By request of Edward F. Searles, to see if the Town will vote to accept a certain parcel of land on Broadway being lots no. 12 and 13, and situated between the Arlington School and Broadway, adjoining the Arlington School lot on the westerly side. This land to be used for school purposes only.

Article 35 By request of Edward F. Searles to see if the Town will vote to accept a certain parcel of land on Tenney Street, being lots no. 175 to 178 inclusive, said land to be forever devoted to the same use as at present,

viz.: - a park or children's play ground. The donor retains the right to improve this park at any future time.

Article 36 By request of Otto Muller and others, to see if the Town will vote to establish a voting precinct in the east part of the Town, including the territory bounded by Jackson Street on the west, Pleasant Valley Street and including the same on the north, Merrimack River from the Haverhill line to Lawrence line on the east, and the Lawrence line to Jackson Street on the south.

Article 37 By request of the Board of Fire Engineers and the Highway Surveyor, to see if the Town will vote to buy a pair of horses to be worked on the streets, and to be used for fire department purposes, when needed, and appropriate five hundred dollars for the same.

Article 38 To see what action the Town will take with regard to the construction of sewers the present year towards the completion of the system already adopted.

Article 39 To see if the Town will vote to hire money for the construction of sewers, and take such action as the Town may think proper.

Article 40 By request of the Water Commissioners, to see if the Town will vote to appropriate from the earnings of the works, the sum of three thousand five hundred (\$3,500) dollars to be placed in the Sinking Fund.

Article 41 By request of Jesse J. Prescott, Highway Surveyor, to see if the Town will vote to appropriate five hundred (500) dollars to widen and grade Forest Street as ordered by the County Commissioners.

Article 42 By request of Jesse J. Prescott, to see if the Town will vote to rebuild a retaining wall in front of the house of C. H. Foss, on Railroad Street, in consideration of a strip of land now used by the Town for a sidewalk, and appropriate fifty (50) dollars for the same.

Article 43 By request of Henry Arnold and others, to see if the Town will vote to pay for labor on the highways at the rate of \$1.75 per day of nine hours, instead of \$1.50 per day as at present.

Article 44 By request of Joseph Morin and Guilford A. Lewis, to see if the Town will vote to grant them 14 days vacation without loss of pay.

Article 45 By request of Guy W. Currier and others, to see if the Town will vote to employ a policeman to remain at the Police Station nights, and to furnish a telephone for said station, and increase the amount appropriate for police to cover expense of same.

Article 46 By request of Samuel Adams Chapter, D.A.R. of Methuen, to see what action the Town will take in regard to the advisability of celebrating in a suitable manner “Old Home Week” in Methuen, whenever appointed by the Governor of the Commonwealth, and choose a committee of five to have charge of the celebration, and to make such appropriation as the Town may deem proper.

Article 47 By request of Samuel Adams Chapter D.A.R. that whereas the location on East and Merrimack Streets, known as Cook’s corner, never having been named by the Town, was purchased from the Indians by the ancestors of the Cross family and has always remained in their possession. We ask that the same be now named “Cross Corner”.

Article 48 By request of Samuel Adams Chapter D.A.R., that whereas in the early settlement of the Town of Methuen, the highway now named Howe Street, was called Howe Road. We ask that the same be changed to the original name, Howe Road.

Article 49 By request of Silas L. Holman, to see if the Town will vote to put in drain for carrying off surface water from Lowell Street, beginning at a point nearly opposite the house of Sutcliffe Crowther, and running to Oakland Avenue; thence to a point on land of C. D. and J. B. Holman, opposite Hawthorne Avenue and appropriate two hundred (200) dollars for the same.

Article 50 To see what action the Town will take in connection with report of Committee recommending changes in methods of conducting Town affairs submitted at last Annual Town Meeting.

Article 51 By request of Mrs. David Nevis and others to see if the Town will appropriate five hundred (500) dollars for the suppression of the Brown Tail Moth and other insects injurious to the shade trees of the Town, said amount to be expended under the direction of the Tree Warden.

Article 52 By request of C. W. Mann, to see if the Town will vote to establish three Sanitarians for public convenience, one near Central Place, one in Railroad Square and one in the Arlington District, and make an appropriation for the same.

Article 53 By request of John E. Sawyer, Postmaster, to see if the Town will vote to repair the following streets, the better to enable the Rural Letter Carriers to deliver the U.S. mail: Riverdale Street from Merrimack Street to its terminus; Cross Street from Pumping Station to Hampshire Road; and Myrtle Street, from West Street, and make an appropriation for the same.

Article 54 By request of Frank W. Payson to see if the Town will vote to lay a pipe on Howe Street from the house of Albert W. Currier to culvert at foot of hill and make an appropriation for the same.

Article 55 By request of Peter Carrow and others, to see if the Town will vote to locate a fire alarm box at the corner of Stevens and Central Streets, and appropriate eighty five (85) dollars for the same.

Article 56 By request of Eben E. Bailey and others to see if the Town will vote to locate a fire alarm box on Miller Street between Milk and Arthur Streets and appropriate one hundred (\$100) dollars for the same.

Article 57 By request of Thomas Doyle, to see if the Town will vote to locate a fire alarm box at the corner of Lawrence and Spruce Streets, and appropriate one hundred and fifty (150) dollars for the same.

Article 58 By request of Richard Irving, to see if the Town will vote to reimburse him sixty five & 60/100 (\$65.60/100) for taxes paid by him on a piece of land sold by him to the Town of Methuen, June 14, 1887 to 1901.

Article 59 By request of Agnes McCartney, to see if the Town will vote to lay flagging across French Street to Centre Street.

Article 60 By request of Heirs of Edward Young, to see if the Town will vote to buy a tract of land containing about seven acres, bounded by land of the Town Farm on three sides, and pay three hundred and fifty (350) dollars for the same.

Article 61 By request of Thomas Hynes, to see if the Town will vote to locate a Welsbach street light at the corner of Elsmere and Edgewood Avenue, and appropriate twenty four (24) dollars for the same.

Article 62 By request of J. T. McLean and others, to see if the Town will vote to establish street lights at Cook's Corner, Bates Street, corner of East, Swan, corner of East Street and appropriate seventy five (75) dollars for the same.

Article 63 By request of German S. Phippen and others, to see if the Town will vote to erect and maintain a street light in Fairview near the fountain, and appropriate eighteen (18) dollars for the same.

Article 64 By request of E. F. Davis and others to see if the Town will vote to erect and maintain street lights at the following places: - corner of Elm and Woodland streets, corner and Woodland and Orchard Streets (Barker's Corner), Orchard Street, between Barker's Corner and Forest Street; corner of Orchard and Lowell Streets, (Smith's Corner); corner Lowell

and Forest Streets, front of Barker school-house, corner of Lowell and North Lowell Streets, and on Lowell Street at Sawyer's Corner, and appropriate one hundred and seventy five (\$75) dollars for the same.

Article 65 By request of Alfred Newsholme and others, to see if the Town will vote to erect and maintain an electric arc light at the junction of Oakland Ave. and Lowell Street, and appropriate seventy (70) dollars for the same.

Article 66 By request of Joseph Bentley and others, to see if the Town will vote to erect and maintain a Welsbach street light on Hawthorne Avenue, opposite the house of Sarah Bentley, and appropriate twenty four (24) dollars for the same.

Article 67 By request of Perley D. Smith and others, to see if the Town will vote to erect and maintain an electric arc light at the corner of Prospect and East Streets, and appropriate seventy dollars for the same.

Article 68 To see if the Town will vote to accept a street as laid out by the Selectmen, running from Mystic Street to Inglewood, to be known as Webb Street.

Article 69 To see if the Town will vote to accept Walnut Street, as laid out by the Selectmen, as shown on plan of Cochrane land.

Article 70 To see if the Town will vote to accept Bryant Avenue as laid out by the Selectmen as shown on a plan of land owned by C. D. and S. L. Holman.

Article 71 To see if the Town will vote to accept the extension of Clossen Court, as laid out by the Selectmen, beginning at its present terminus and extending 100 feet.

Article 72 By request of Arthur Redford and others, to see if the Town will vote to locate a fire alarm box at corner of Myrtle and Tyler Streets, and appropriate one hundred (100) dollars for the same.

Article 73 By request of A. A. Spofford and others, to see if the Town will vote to Macadamize Quincy Street from East to Swan Streets, and make an appropriation for the same.

Hereof fail not and make due return of this warrant, with your doings thereon to the Town Clerk on or before the time from the meeting aforesaid.

Record of Business Meeting, March Seventh 1903

Pursuant to the foregoing Warrant, a meeting of the Inhabitants of the Town of Methuen, qualified to vote in elections and in Town affairs, was held in the Town Hall in said Town, on Saturday the seventh day of March A.D. 1903, at one o'clock in the afternoon, to elect Town Officers not chosen by ballot, and to transact the business of the Annual Town Meeting.

Action on the estimate for Macadam was postponed until after section on subsequent articles. The estimate for sidewalks was increased to two thousand dollars - one thousand to be used for permanent sidewalks. The estimate for Tree Warden was postponed until action should be taken on a subsequent article.

Article 5 **Collection of Taxes**

Voted: - That taxes be collected the same as last year, and that on all taxes remaining unpaid after October first, interest shall be paid from that date to the time of payment at the rate of six per cent per annum.

Article 6 **Temporary Loans**

Voted: - By a unanimous vote, that for the purpose of procuring a temporary loan to and for the use of the Town of Methuen in anticipation of the taxes of the present municipal year, the Town Treasurer is hereby authorized and directed to borrow from time to time, with the approval of the Board of Selectmen, a sum or sums not exceeding in the aggregate sixty thousand dollars, and to execute and deliver the note or notes of the Town therefor, payable within one year from the time the loan is made. Any debt or debts incurred by a loan or loans to the Town under this vote, shall be paid from the said taxes of the present municipal year.

Article 7 **Jury List**

Article 1 **Collection of Taxes**

Voted: that taxes be collected the same as last year and that on all taxes remaining unpaid after October first, interest shall be paid from that date to the time of payment at the rate of six per cent per annum.

Article 6 **Temporary Loans**

Whereas a bill is now pending in the Legislature, entitled An Act to include the Towns of Andover, North Andover and Methuen within the Jurisdiction of the Police Court of Lawrence. Therefore, Resolved by the Legal Voters of Methuen at their Annual Town Meeting assembled, - That

we are opposed to the merging of our Police Court with that of Lawrence, as it would be inconvenient and would incur a large additional expense.

Resolved, that our Representatives in the Legislature be instructed to oppose said bill, as in our judgment it would be detrimental to the interest of Methuen, should it become a law.

In accordance with the above vote, a certified copy of the above Resolutions was handed to Representative Castle, to be presented by him to the Committee of the Legislature having charge of the bill.

Voted, that the School Committee be authorized and instructed to procure a deed of said land from Mr. Bradley, and that two citizens be added to the Committee. The chair appointed Edward A. Archibald & Wm. H. Craven. Mr. Richardson moved that none but Methuen citizens be employed upon the work, and the motion was laid upon the table.

Article 19 **East School House**

Voted to authorize the same Committee to repair the old East School building and put the same into reasonable safe and sanitary condition, and appropriate therefor the sum of thirty five hundred dollars.

Article 20 **School House Loan**

Voted, by a unanimous vote, that for the purpose of paying for the construction and equipment of the school house.

Voted to be built on the Bradley Farm, and the repairs voted to be made on the East School Building, the Town Treasurer is hereby authorized and directed to borrow with the approval of the Board of Selectmen, the sum of eighty five hundred dollars, and to execute and deliver the notes of the Town therefor, payable in twenty years from the date of issue, with

interest thereon at the rate of four per cent per annum payable semi-annually.

Voted – that the Selectmen and Town Treasurer constitute the commission to carry out this vote and that they be authorized and instructed to make such investments as they shall deem for the best interests of the Town.

Article 29 Fire Dept. Wagon

After considerable discussion the Town refused to vote to purchase a combination wagon, or to make any appropriation therefor.

Article 30 Hose & Reel

Voted – To pass over Article 30 of the Warrant.

Voted, that the Hose and Reel now kept on premises of Joseph E. Buswell be transferred and housed at a convenient location in Pleasant View.

Article 31 Fire Alarm Box

Article 31 came up for consideration and considerable opposition developed against it. The point of order was made that no detailed statement of estimated expense was presented to the meeting, and the article was laid upon the table. It was afterwards taken from the table at

an estimated cost of 75.00 was handed the Moderator. The point of order was again made and the Moderator sustained the point of order on the ground that no estimate of expense had been made when the article came up for action by the meeting and the subject was dropped. Subsequently the article was again taken up and it was voted, to locate a fire alarm box on Lowell Street, near Morse Brothers, and that the cost thereof be taken from the regular appropriation for the Fire Department.

Article 32 **Survey of Town**

Voted to refer Article 32 to the Selectmen and the Town Clerk to be reported on at the next Annual Town Meeting.

Article 33 **Sale of land**

Voted to pass over Article 33 of the Warrant.

Article 34 **Sewer in Chelmsford St.**

Voted, - that the thanks of the Town be extended to the ladies of the Samuel Adams Chapter, for their agency in this matter.

Article 41 Drinking Fountain

Voted, that the drinking fountain situated at the corner of the Park and Howe Street, be removed from its present location to the corner of Jackson and Pleasant Streets, and that the work be done under supervision of Water Board. Isaac C. Brown said he would pay expenses.

Article 42 Albion St.

Voted, to change the name of that part of Baremeadow Street, between Prospect Street and Milk Street, to Albion Street.

Article 43 Tax Deeds

Voted, to authorize the Town Treasurer to sign and execute deeds of land redeemed after tax sale, and purchase by the Town.

Article 44 Cochrane St.

Voted, - to accept a part of Cochrane Street as laid out by the Selectmen.

Articles 45, 46, 47, 50 and 51 were reported on favorably by the Committee on Finance, and were referred to the Old Committee on Street Lighting with full power, and the sum of one hundred and sixty five dollars was appropriated.

Originally appointed Sept. 25, 1897.

Voted – that the Moderator appoint a member of the Committee in place of Frank Buckminster. George McLane, 23 Barker St. was appointed.

Voted, to pass over Articles 48, 49 and 52 of the Warrant.

John S. Tapley was appointed Surveyor of Wood and Bark and Public Weigher.

The Chair appointed Edward A. Archibald and William H. Craven, the additional members of Committee on building School House.

Voted, - that all Committees whose duties are completed be discharged. Mr. Lyons presented a petition for removal of Arc light on Chase St. A remonstrance was also presented. Both papers were referred to the Selectmen with full power.

In Memoriam

**Died on the twenty first day of March A.D. 1904 George O. Marsh, who had
been elected**

Selectman, Assessor and Overseer of the Poor for the current year.

**Mr. Marsh was first elected in 1883 and his election for the present year,
was the sixteenth one
of the longest terms of service in the annals of the Town. It is doubtful too,
if any Selectman has
ever before died in office. Mr. Marsh was born in Hudson, N.H. and came
to Methuen when
three years of age, has resided here ever since, and died at the age of seventy
year.**

**He attended Town Meeting on Saturday March 12 apparently in his usual
health. He sat next
the center aisle, where there was a draught of air through the hall and
contracted a cold which
developed into pneumonia, causing his death on Monday March 21st. His
death is a great loss to
the Town.**

**Endowed as he was with good natural ability his long service gave him an
experience in Town
matters which was of great value to his townsmen. As a Town officer he
was thoroughly honest**

and impartial, not allowing his prejudices to swerve his judgment, or his temper to control his action when people were unreasonable and irritating. His judgment of real estate was exceptionally good, and he was more familiar with land ownership in the Town, than any other man in it. As Overseer of the Poor, his services were particularly valuable. He was very familiar with the pauper laws, having had that department of the Town business under his special charge most of the time during his service. He was sympathetic with the poor and destitute and yet did not allow his sympathies to run away with his discretion. Few men could draw the line between the deserving poor, and the idle, improvident pauper so accurately as he. He was thoroughly honest and sincere and had the best interests of the Town at heart, in all he did. A kind father, a staunch friend, a generous public spirited citizen, a faithful public servant and an honest man his memory will long be cherished by those who knew him.
